



As the country continuously steps up efforts to transition to a new normal amid the COVID-19 pandemic and as part of the sustained management against COVID-19, the National Government, through a whole-of-government and whole-of-society approach, needs to ensure constant vaccination information drive to each and every Filipino.

In November 29, 2021, the Philippine Food and Drug Administration (FDA) issued an amendment on the Emergency Use Authorization (EUA) for administration of homologous and heterologous additional doses to eligible fully vaccinated individuals for the National COVID-19 Vaccine Deployment Program.
