



PARTICIPATION TO THE QUALITY ASSURANCE AND FINALIZATION OF THE SELF-LEARNING MODULES (SLMs) WORKSHOP

To: Schools Division Superintendents
All Others Concerned

- 1. This is in reference to the attached Letter from Candice Elaine Bismonte, dated June 16, 2022, Project Manager, Safe Schools 3, Plan International Philippines, requesting the participation of the Curriculum and Learning Management Division (CLMD) and Teacher-Writers in the Quality Assurance and Finalization of the Self-Learning Modules (SLMs) Workshop on July 6-8, 2022 in Tacloban City.

Our sincerest gratitude for the support Department of Education Region VIII has provided in the implementation of the Safe Schools 3 project.

In line with Risk Reduction and Resilience Education Pillar of the Comprehensive School Safety Framework and in support to DepEd's Learning Continuity, the Safe Schools project has enhanced Self-Learning Modules (SLMs) to integrate disaster risk management, climate change adaptation, school safety concepts and pandemic preparedness key messages.
