# PROCUREMENT FOR THE UPGRADING OF ICT NETWORK INFRASTRUCTURE (2ND PHASE)

The Department of Education Regional Office VIII, through the General Appropriations Act CY 2022 intends to apply the sum of One Million Pesos Only (₱1,000,000.00), being the Approved Budget for the Contract (ABC) corresponding to the total amount of the three (3) Lots for the PROCUREMENT FOR THE UPGRADING OF ICT NETWORK INFRASTRUCTURE (2ND PHASE) with the detailed payments under the contract for each lot indicated in the table below. Bids received in excess of the ABC per LOT shall automatically be rejected in accordance with Sec. 31.1 of the Revised IRR of RA 9184 at bid opening.

- Delivery shall be within Sixty (60) Calendar Days for Lots 1 and 2, and Thirty (30) Calendar Days for Lot 3, from suppliers' receipt of the Notice to Proceed (NTP).
- 2. The Department of Education, Regional Office VIII now invites bids for the PROCUREMENT FOR THE UPGRADING OF ICT NETWORK INFRASTRUCTURE (2ND PHASE). Delivery of Goods is required within Sixty (60) Calendar Days for LOTS 1 and 2 while Thirty Calendar Days for LOT 3. Bidders should have completed, within the last Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from the Department of Education Regional Office VIII and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by the interested bidders on JULY 19, 2022, from DepEd Regional Office No. VIII, BAC Secretariat, located at Government Center, Candahug, Palo, Leyte, and DepEd Regional Office No. VIII website, <a href="region8.deped.gov.ph">region8.deped.gov.ph</a>. and upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (PhP 1,000.00) for LOT 1, Five Hundred Pesos (PhP 500.00) for LOT 2 and Five Hundred Pesos (PhP 500.00) for LOT 3. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person to the DepEd Regional Office No. VIII Cashier or through online banking.

- 6. The Department of Education, Regional Office VIII will hold a **Pre-Bid Conference** on **JULY 28, 2022, 1:00 PM** at the **DepEd Regional Office VIII, Candahug, Palo, Leyte**, through video conferencing via **MICROSOFT TEAMS**, which shall be open to prospective bidders.
- 7. Bids must be received by the BAC Secretariat, DepEd Regional Office VIII, Candahug, Palo, Leyte 6501 either through manual/physical submission or through courier on or before 10:00 a.m. of AUGUST 11, 2022. Late Bids shall not be accepted.
- 8. All bids must be accompanied by a Bid Securing Declaration, or any form of Bid Security and amount indicated in ITB Clause 14.
- 9. **Bid opening** shall be on **AUGUST 11, 2022; 10:15 AM FOR LOTS 1-3 at the DepEd Regional Office VIII, Candahug, Palo, Leyte.** Bids will be opened in the virtual presence of the bidders' representatives who choose to attend the activity. *Physical attendance of bidders/representatives during the Pre-Bid Conference/Bid Opening activities shall not be allowed during the COVID-19 pandemic.*
- 10. Participants are informed that the Pre-Bid Conference and Opening of Bids during the COVID-19 Pandemic shall be broadcasted/shared to prospective bidders who wish to attend the said procurement activities online, via Microsoft Teams.
