CONTRACT AGREEMENT

THIS AGREEMENT made the 24 day of SEP 2022 between **DEPARTMENT OF EDUCATION REGIONAL OFFICE VIII**, represented by **DR. EVELYN R. FETALVERO, CESO IV**, in her capacity as the **REGIONAL DIRECTOR** of the **DEPED RO VIII**, hereinafter referred to as the "**Entity**"; and **KNG PHARMACEUTICAL SUPPLY** of Quezon City hereinafter called "the Supplier) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF VARIOUS SUPPLIES FOR THE PROTECTION AGAINST COVID-19, LOT 3-MEDICINES**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Philippine Pesos Three Hundred Thirty Eight Thousand Seven Hundred Pesos (Php 338,700.00) only**, hereinafter called "the Contract Price".

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;

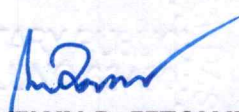

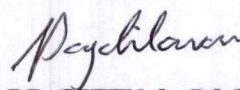

In consideration for the sum of **Philippine Pesos Three Hundred Thirty Eight Thousand Seven Hundred Pesos (Php 338,700.00) only** or such other sums as may be ascertained. **KNG PHARMACEUTICAL SUPPLY** agrees to the **PROCUREMENT OF VARIOUS SUPPLIES FOR THE PROTECTION AGAINST COVID-19, LOT 3-MEDICINES** in accordance with his/her/its Bid.
4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby enters into a covenant with the Entity to execute and complete the Works within a period of **SIXTY (60) CALENDAR DAYS** in conformity with the provisions of this Contract in all respects, and in accordance with governing laws, rules and regulations.
5. The Head of the Procuring Entity (HOPE) DR. EVELYN R. FETALVERO, CESO IV, in her capacity as the REGIONAL DIRECTOR of the DEPED RO VIII agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

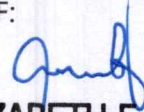
