



# REGIONAL QUALITY ASSURANCE AND CONTENT REVIEW OF THE SELF-LEARNING MODULES FOR THE ADD-ON SUBJECTS UNDER THE SCIENCE, TECHNOLOGY, AND ENGINEERING (STE) PROGRAM

To: Schools Division Superintendents
School Heads – STE Implementing Schools
All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division, shall conduct the Regional Quality Assurance and Content Review of the Self-Learning Modules (SLMs) for the Add-on Subjects under the Science, Technology, and Engineering (STE) Program on August 2 5, 2022 at the Milka Hotel, Brgy. Abucay, Tacloban City, Leyte.
- 2. The activity aims to:
  - a. reorient the content reviewers on the guidelines in the development and quality assurance of SLMs;
  - b. quality assure content review the division submitted SLMs for the STE add-on subjects; and
  - c. address other issues, gaps, and concerns related to STE SLMs development.
- 3. Relative to Regional Memorandum No. 656, s. 2021, re: "Submission of the SLMs for the Add-on Subjects Under the STE Program," it is reiterated that the Schools Division Offices are required to submit the soft copy of the division level quality assured SLMs. Extension of the submission is set until **July 25, 2022,** 5:00 p.m. through sharing of the division Google Drive containing the said SLMs to clmd.region8@deped.gov.ph cc ryan.tiu@deped.gov.ph. The non-submission requires a justification letter and catch-up activity timeline to be submitted through the Schools Division Superintendent.
- 4. The participants to this activity are the Regional Education Program Supervisors for LRMS and Science, one CLMD staff secretariat, and identified STE QA Content Reviewers, as per attached list. They are required to bring laptops, extension wire, internet modem or portable Wi-Fi device for back-up internet connectivity, references in soft or hard copies, face masks, and COVID-19 vaccination card.
