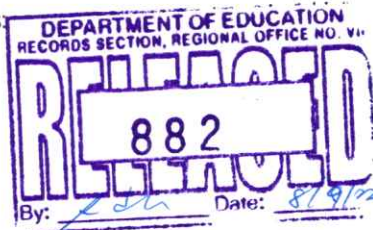

In reference to DO 10, S. 2022 dated March 11, 2022 re: Supplementary Guidelines on DO 31, s. 2021 (Operational Guidelines on the Implementation of the School-Based Feeding Program), the implementation period for FY 2022 funds is recommended from April to July 2022.
