1. In reference to the approved Securities and Exchange Commission (SEC) Registration with Registration No. 41488 of **BAROBAYBAY ACADEMY-MISSION SCHOOL, INC.** located in Barobaybay, Lavezares, Northern Samar, Philippines this Office, through the Quality Assurance Division (QAD) announces the change of name of the school from **BAROBAYBAY ACADEMY INC. TO BAROBAYBAY ACADEMY-MISSION SCHOOL, INC.** effective **September 8, 2022.**

2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage of the residents of the community, be placed beneath the new name as follows:

(Formerly: Barobaybay Academy Inc.)

Thus, Government Recognition Nos. 015, s. 2002 for Junior High School, and Provisional Permit No. 102 s.2015 for Senior High School respectively remain legal and official.

4. The Schools Division Superintendent of Northern Samar Division shall ensure the updating of data and profile of the school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and monitor the implementation of said issuance.

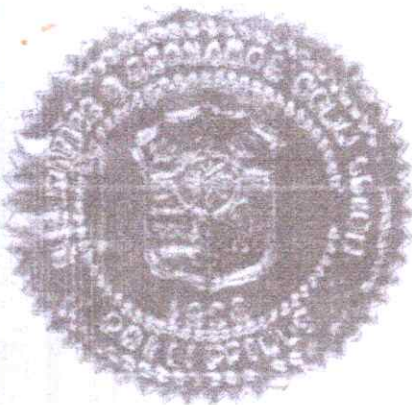

**AMENDED ARTICLES OF INCORPORATION  
OF**

**BAROBAYBAY ACADEMY-MISSION SCHOOL, INC.**

**(FORMERLY BAROBAYBAY ACADEMY INC.)**

**KNOW ALL MEN BY THESE PRESENTS:**

We, all of whom are of legal age, citizen and residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a non-stock corporation under the laws of the Philippines.

**AND WE HEREBY CERTIFY:**

- I. That the name of the said corporation shall be BAROBAYBAY ACADEMY-MISSION SCHOOL, INC. *(as amended by the Board of Trustees on September 13, 2015)*
- II. That the purpose for which said corporation is formed are: To establish, maintain and operate Secondary Education specifically Junior and Senior High School, for the purpose of training the youth of the Philippines in the Catholic Faith and in the ideals of democracy, with a view to developing God-fearing, law-abiding and useful citizens. *(as amended by the Board of Trustees on September 13, 2015)*

**INCIDENTAL PURPOSES**

To organize, operate and maintain foundations, stores, canteens, printing and publishing establishments, laboratories, shops, vocational crafts, animal husbandry, agricultural and industrial projects, and water transportation for the exclusive use of the school, or otherwise engage in any activity connected with the growth and development of the school or which may be directly or indirectly incidental or conducive to the attainment of the primary objective hereinabove mentioned.

To purchase, acquire, hold, sell, lease exchange mortgage or otherwise deal in real and personal property, and to construct, acquire, lease, purchase or mortgage buildings and offices, open up branches anywhere in the Philippines as may be necessary or useful to carry out educational objectives and purposes of this corporation.

It is understood that all the above mentioned purposes shall be carried out or implemented only in accordance with, and always subject to the laws of the Republic of the Philippines, and the rules and regulations that may be promulgated by competent authority.

- III. That the place where the academy, school or institution of learning is to be conducted and the principal office is located, shall be in the Barrio of Barobaybay, Lavezares, Northern Samar, Philippines and extension office at

- VII. That the sum of eleven thousand three hundred seventy four pesos and thirty eight centavos (P 11, 374. 38) which represent the funds of the corporation known as initial revolving fund for the maintenance and support of the school.
- VIII. That Faculties and Staff who have rendered a continuous and effective services in this institution for 20 years are entitled of a retirement CEAP Pension plan.  
*(as amended by the Board of Trustees on September 13, 2015)*
