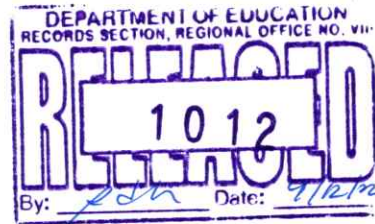

One of the program monitoring initiatives of the Bureau of Human Resource and Organizational Development – School Effectiveness Division is to report the status of filling-up of newly created teaching items from FY 2016-2022, pursuant to the implementation of the Special Provision (SP) of the FY 2022 General Appropriations Act (GAA).

The Department enjoins the field offices in the timely filling-up and reporting of teacher deployment vis-à-vis the number of created teaching items. The remaining unfilled items pose a challenge in the budget utilization rate of DepEd as well as approval for subsequent proposal of teaching item requests to the Department of Budget and Management (DBM).

As of August 31, 2022, **2,149** newly-created teaching items from **FY 2016-2021** remain unfilled (*refer to Table 1*). The data also show that **no region** achieved a 100% filling-up rate for the newly-created teaching items. Thus, all SDOs which are yet to achieve a 100% rate in filling-up newly-created positions are instructed to update the status of filling-up from FY 2016-2021.

Kindly note that all presented data are generated from the Program Management Information System (PMIS) which is used for program level monitoring.

It is requested from the **Schools Division Offices (SDOs)** to **regularly update the reporting of the filling-up of teaching items upon appointment**, in the following:

- a. **PMIS.** Updating from FY 2019-2022 shall be made every 15th and 30th of the month.
- b. **GMIS.** Updating for the Personal Services Itemization and Plantilla of Personnel (PSIPOP), as per DBM's National Budget Circular No. 549 dated October 21, 2013, shall be made every 5th of the month.

The requested updates will be used as a basis to determine Personnel Services requirements for both filled and unfilled positions, and as necessary for FY 2023 budget preparation.
