REGIONAL CELEBRATION OF THE WORLD TEACHERS DAY

1. Marking the anniversary of the adoption of the 1966 UNESCO Recommendation concerning the Status of Teachers, **The World Teachers Day** is commemorated every October 5 annually. This year's celebration is anchored on the theme "**Gurong Pilipino, Dangal ng Sambayanang Pilipino.**" The theme explains the vital role that teachers play in guiding and preparing the younger generation to be equipped with the knowledge to deal with the challenges of the times.
