With reference to **DM-CI-2022-231 RE: Professional Development Course for Spanish Teachers** dated August 1, 2022, the schedules for the conduct of the training shall be changed due to the Memorandum issued by the Office of the Secretary dated August 22, 2022, with the subject **Reschedule of the Conduct of Trainings, Workshops, Seminars, and Participation to Meetings and other Engagements that will Require Officials and Employees to Leave their Workstations.**

The following are the new schedules:

1. The first course is from September 20 to October 20 - Structure 30 hours online lessons. 6 hours per week. Two sessions of 3 hours. Tuesdays and Thursdays. From 9 am to 12 noon.
2. The second course is from November 3 to December 6 - Structure 30 hours online lessons. 5 hours per week. Two sessions of 3 hours. Tuesdays and Thursdays from 9 am to 12 noon.

In addition, recognizing the efforts and support of the teachers in the implementation of SPFL-Spanish in their schools, the teachers are eligible to avail of service credits commensurate to the number of hours/days of the training as scheduled, pursuant to DepEd Order No. 5, s. 2003 titled Updated Guidelines on Grant of Vacation Service to Credits to Teachers. Further, given the schedule of the courses, school heads are requested to ensure that there will be no conflict with the teachers' teaching assignments.

All other provisions stated in the Memorandum shall remain the same.
