- The SDOs and concerned schools may refer to Regional Memorandum 543, s. 2021 2. and Regional Memorandum 753, s. 2022 to check the list of recipients of the SPED-PSF and the amount that each SDO or school is supposed to receive for the two fiscal years. The recipient SDOs and schools are also advised to coordinate with their Finance Divisions to ensure that the utilization reports that will be submitted are accurate and updated.
- The deadline for submission of the utilization reports shall be October 7, 2022 for FY 2021 and January 31, 2023 for FY 2022.
