
1. In accordance with DepEd Order No. 003, s. 2021, entitled: Creation of the Child Protection Unit and the Child Rights in Education Desk in the Department of Education and pursuant to the 1987 Constitution, the State shall protect and promote the right of all children to accessible and quality basic education. Alongside this right is the constitutional policy that the State shall promote and protect their holistic development through the promotion of their physical, moral, spiritual, intellectual, and social well-being.
2. Pursuant thereto, **ATTY. SUZETTE T. GANNABAN-MEDINA** is hereby designated as the Officer-In-Charge Director III, Head of the Child Protection Unit (CPU), effective immediately, until such designation is revoked.
3. Atty. Medina shall supervise the activities and deliverables of the CPU and shall report directly to the Assistant Secretary and Undersecretary for Governance and Field Operations.
4. Atty. Medina shall sign official correspondences in the following manner:

5. As OIC, Atty. Medina shall be allowed to receive Representation and Transportation Allowances (RATA), except the salary of the position.
