## RENAMING OF BAYBAY ADVENTIST MULTIGRADE SCHOOL TO BAYBAY ADVENTIST ELEMENTARY SCHOOL INC. WITH SCHOOL ID 404660

- 1. In reference to the Amended Articles of Incorporation approved by the Securities and Exchange Commission (SEC) and request for the renaming of school by the School Head, the Department of Education Regional Office No. VIII through the Quality Assurance Division (QAD) announces the change of the name of the school from **Baybay Adventist Multigrade** School to **Baybay Adventist Elementary School Inc.**, Baybay City with School ID 404660 effective **November 2**, 2022.
- 2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage by the residents of the community, be placed beneath the new name as follows:

#### BAYBAY ADVENTIST ELEMENTARY SCHOOL INC.

(Formerly Baybay Adventist Multigrade School)

- 3. The change of name does not instill any deviations on the provisions of the Government Recognition (GR) given to the said school. Thus, Government Recognition No. 06, s. 1995 for Elementary Grades I-VI and Government Recognition No. 07 s. 1998 Pre-Elementary, still remain legal and official.
- 4. Copies of this issuance shall be posted at the Regional Office, Division Offices, Municipality/City Halls, Schools, and other conspicuous places for reference and information of the general public.
- 5. The Schools Division Superintendent of Baybay City Division is advised to facilitate the updating of data and profile of the aforementioned school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and monitor the implementation of this issuance.





We, the undersigned incorporators, all of legal age, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

#### THAT WE HEREBY CERTIFY

Article I That the name of this association shall be

Baybay Adventist Elementary School Inc.

Article II: That the purpose for which this association is formed are:

#### Primary Purpose:

1. The ultimate purpose of the corporation is to offer Christian Education through the operation of complete pre-elementary and elementary courses to cater the intellectual, physical, psychological, social and spiritual needs of the students in order that their educational experience will prepare them for service to the glory of God and their fellowmen in the community, as well as for a life of greater service in the hereafter.
