Details on this event can be found in the said letter.

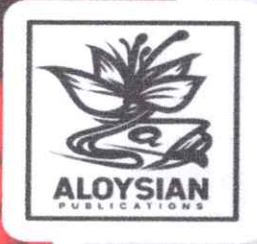
