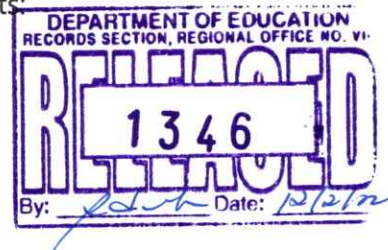

The non-teaching personnel, including management staff, shall be provided with CTO per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Curricular No. 02 s, 2004 on Non-Monetary Remuneration for Overtime Service Rendered.

Furthermore, the CTO shall be subject to existing rules and regulations of the Department of Education (DepEd) and shall be approved by their respective Schools Division Offices.
