CONTEST GUIDELINES

In order to engage the DepEd community's interest and awareness regarding the ASEAN community and sustainable development goals at the regional level, various activities are conducted. These activities are aligned to the theme "ASEAN ACT: Addressing Challenges Together" which underscores ASEAN's spirit of "Togetherness" as one community and the common will in our collective endeavor to address and overcome challenges facing our region, aligned with UN's mission to build peace, eradicate poverty, and drive sustainable development covering five major themes to its programs which include education, natural sciences, social and human sciences, culture, and communication and information.

This year, three activities shall be conducted and participated by DepEd Region VIII personnel. Below are the details of each activity.

1. DIGITAL POSTER MAKING CONTEST

Eligibility:

- a. There shall be only one participant per Schools Division.
- b. Participant must be a teaching, teaching-related or non-teaching personnel.

Registration:

- a. Interested participants must register using the link: bit.ly/ASEANR8Reg
- b. Deadline of registration: December 23, 2022.

Rules:

- a. Each participant shall submit only ONE entry.
- b. The poster must illustrate, interpret and accentuate the theme.
- c. The participants may use any editing software.
- d. Posters to be submitted must have the following specifications:
 - Size of the poster must be in a Long size (8.5" x 13")
 - Quality shall be between 300-600 DPI
 - Must be in Portrait orientation
 - Must be original/authentic and does not use elements on the poster which could be subjected to copyright infringement.
 - Must attach a 200-word description/explanation of the poster.
 - Must attach a photo of the participant holding the printed poster.
- e. Deadline of submission: December 26, 2022, 10:00AM

Originality and Creativity	Clearly shows the uniqueness of idea	20%
Aesthetic appeal	Considers the aesthetic principles of symmetry, focal point, pattern, perspective, dimensionality, and proportion	40%
Message	Clearly describes the participant's intent for the poster created.	10%

2. DIGITAL PHOTO COMPETITION

Eligibility:

- a. There shall be only one participant per Schools Division.
- b. Participant must be a teaching, teaching-related or non-teaching personnel.

Registration:

- a. Interested participants must register using the link: bit.ly/ASEANR8Reg
- b. Deadline of registration: December 23, 2022.

Rules:

- a. Each participant shall submit only ONE entry.
- b. The digital photo must center on the portrayal of subject/s on the culture of the assigned ASEAN member country per Schools Division.

- c. To ensure that ethical standards are observed, the following must be attached.
 - Letter of consent from the subject/s
 - Letter of authenticity of the photo taken personally by the participant
- d. The participants may use digital camera, smart phone or any gadget with camera.
- e. Photos must not be previously taken or published.
- f. Photos submitted must be in high resolution (minimum of 4 MB) and in portrait orientation.
- g. Caption of the photo with at least 200 words must be attached. This shall explain/describe the photo.
- h. Entries using advertising or offensive images, as evaluated by the panel of judges, shall be disqualified from the contest.
- i. Deadline of submission: December 26, 2022, 10:00AM.

3. UN DINER CONTEST

Eligibility:

- a. There shall be only two participant per Schools Division.
- b. Participant must be a teaching, teaching-related or non-teaching personnel.

Registration:

- a. Interested participants must register using the link: bit.ly/ASEANR8Reg
- b. Deadline of registration: December 23, 2022.
- c. Only the first 10 registered Schools Division shall be accepted in the competition.

Rules:

- a. Participants per Schools Division shall present only ONE entry.
- b. Each team shall present a prepared snack inspired from the appetizers/snacks of any UN member country, except the Philippines.
- c. The prepared snack can be pastry or any delicacy which do not require heating the food at the venue. This must also be paired with a beverage.
- d. Each team must prepare the snack good for 20 pax (1 plated for display)
- e. The participants are requested to wear proper food service attire and must observe proper etiquette in the preparation and serving of the food.

- f. For validation purposes, a time lapsed video on the preparation/cooking of the food is requested. This video must be submitted through the online link which will be provided during the Day 0 of the activity.
- g. The participants must provide a Title Card which contains the title and the brief description of snack on display. This must be submitted together with the Recipe Form.
- h. The title card must be placed on the display area of the participants' snack prior to judging.
- i. The prepared snacks shall be served to the participants where they shall vote for the People's Choice Awardee.
- j. The panel of judges shall rate the prepared snacks based on the rubrics.

Rubric for Judging:

Creativity	Ingenious approach on the dish from a UN member country	20%
