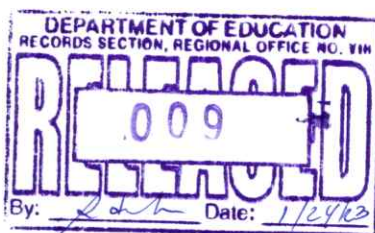
TABOAN SA DSWD OTSO
