THE LUNDUYAN SA KAHUSAYAN**

1. Attached is Memorandum DDM-OUHROD-2022-0603, from Undersecretary Revsee A. Escobedo for Governance and Field Technical Operations and Officer-in-Charge of the Office of the Undersecretary for Human Resource and Organizational Development, informing all Lunduyan Cohort 2 non-completers of a second opportunity to complete their training courses through the upcoming Cohort 4 of the Lunduyan sa Kahusayan.

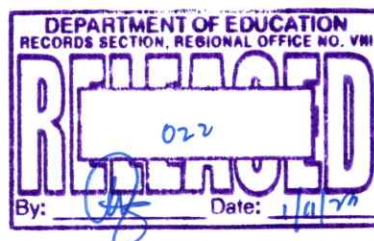

SUBJECT : **Reminder for Lunduyan Cohort 2 Non-Completers and Other Relevant Information on the Implementation of Lunduyan sa Kahusayan**

1. The National Educators Academy of the Philippines (NEAP) in collaboration with the National Teachers College (NTC) has implemented Lunduyan sa Kahusayan training program for Cohort 2 participants from July 4 to August 19, 2022.
 2. Relative to the Cohort 2 Lunduyan implementation, **341 Professional Development (PD) participants were tagged as non-completers.** As stated in DM 82 s. 2020 or the "Guidelines on the Registration of Teachers and School Leaders for NEAP- Recognized Professional Development Programs and Courses", and in the scholar's NEAP PDP contract, scholars are expected to *maintain the academic standards and other course requirements set for by the program.* Otherwise, the scholars need to *refund in full to DepEd such sum of money as may have been defrayed by the Philippine government for expenses incidental for having attended the program or course, for failure to comply with any of the foregoing conditions.*
 3. NEAP and NTC will provide a second opportunity for the tagged cohort 2 non-completer participants (see Enclosure 1) to complete their training courses. An initial communication was sent to all in the list, encouraging them to join the cohort 3. Those who have not signified yet their intention to complete the program are asked to join the upcoming cohort 4 of Lunduyan sa Kahusayan. To ensure the

privacy of the data, regional and division offices are requested to individually notify the concerned scholars.

4. The activity aims to:
 - a. provide chance to all the cohort 2 non-completers to finish their training program in Lunduyan sa Kahusayan; and
 - b. keep away the non-completer PD participants from the burden of refunding to DepEd the amount of the training program
5. The non-completers may email to NEAP - PDD - Delivery and Implementation Unit, through pdd.pdi@deped.gov.ph, their intention of completing the course. NTC will contact the interested participants through their registered email addresses regarding the details of the activity.
6. Additionally, we are again sharing the important links for the NEAP - PD programs batch 2 (see Enclosure 2). We request the assistance of the **regional focal persons** to upload in the google drive folder assigned to each region the submitted documents of the participants and update the tracker for the submitted documents **on or before January 20, 2023**.
