

1. With reference to Regional Memorandum No. 1297, s. 2022 and in adherence with DepEd Order No. 16, s. 2017 *re* Research Management Guidelines (RMG), this Office, through the Regional Research Committee (RRC) and Policy, Planning, and Research Division (PPRD), extends the **Submission of Education Research Proposals for 2023 Basic Education Research Fund (BERF) Grant** from the Policy Research Program of the Regional Office (RO) from December 23, 2022 until February 10, 2023. CALL FOR SUBMISSION OF EDUCATION RESEARCH PROPOSALS FOR 2023 BASIC EDUCATION RESEARCH FUND (BERF) GRANT

- 1. In adherence with DepEd Order No. 16, s. 2017 *re* Research Management Guidelines (RMG), this Office, through the Regional Research Committee and Policy, Planning, and Research Division (PPRD), calls for **Submission of Education Research Proposals for 2023 Basic Education Research Fund (BERF) Grant** from the Policy Research Program of the Regional Office (RO). Screened proposals shall be submitted in electronic PDF copy/format on or before December 23, 2022 through the link: https://bit.ly/2023BERFProposals.
- 2. Relative to this, the Schools Division Research Committees (SDRCs) shall conduct the following preliminary activities anchored on the requirements of the RMG:
 - a. initiate a call for submission of research from schools and Community Learning Centers (CLCs) in their respective divisions;
 - evaluate and approve research proposals submitted by schools and CLCs based on the evaluation using the guides for appraising research proposals; and
 - c. endorse to RO evaluated research proposals.
- 3. The research proposals officially endorsed by the Schools Division Office shall be submitted along with the following requirements/attachments. The Division Research Coordinators shall facilitate the uploading/submission of the requirements.
 - a. Endorsement letter of Schools Division Superintendent;
 - b. Evaluation tool signed by the members of the SDRC;
 - c. Application form and endorsement of immediate supervisor of the proponent;
 - d. Research proposal following the minimum requirements;
 - e. Declaration of anti-plagiarism; and
 - f. Declaration of absence of conflict of interest.
