

Procedure and Criteria for Selecting the "DISTINGUISHED FAPSA NATIONAL LEADERS AND TEACHERS"

OVERVIEW

The distinction/merit for FAPSA NATIONAL LEADERS and TEACHERS to include the private school owners, administrators and teachers, among others is an opportunity for all stakeholders to share the remarkable stories about the excellence displayed with their respective private schools. Individuals recognized will exemplify the strengths, integrity, and leadership of our schools, the support and commitment of the community, and the many notable outcomes of our efforts to deliver and improve Private School Education in the country. Nominations shall be made by the private school administrators and local FAPSA Officer. Final winners will be notified via Email and Phone by the judging team. Accurate email addresses and phone numbers are required for the honor to be considered.

PROCEDURE

- 1. Each private school shall device its own method for selecting its nominees based on the criteria listed herein;
- There shall only be one (1) nominee for each department, namely: (a)
 Preschool [Nursery, Kindergarten, or Preparatory]; (b) Elementary; (c)
 Junior High School; (d) Senior High School; and (e) Tertiary, for each
 private school;
- For the teachers from the private basic education from Preschool to Senior High School, the teacher must be a holder of unexpired professional license; and for the private tertiary level, the teacher must be a graduate of least master's degree;
- 4. The distinction/merit will be given during the FAPSA 25th Anniversary on February 02, 2023 (Thursday) at the Manila Hotel;

- 5. For the private school administrator, he/she must secure a recommendation letter from the President of the local private school association and from the local FAPSA Officer, and for the teacher, he/she must secure a recommendation letter from the private school administrator;
- 6. Once the documents are completed, the private school administrator must submit the said documents to fapsa.com@gmail.com;

7. Deadline of submission:

Date: December 31, 2022

Time: 11:59 p.m.

Notice of Confirmation: January 5, 2023

8. FAPSA Judging team will send an email notification with a list of all award finalists on or before January 5, 2023. In the meantime, we kindly request that you refrain from calling or emailing the office for updates. We look forward to seeing you at the FAPSA ANNUAL CONVERGENCE at the Manila Hotel on February 2, 2023. Please visit the FAPSA website for more details.

GUIDELINES

- 1. The nominee should prepare a profile including the following required documents.
- 2. A reflective statement of up to five hundred (500) words describing personal Administrative/teaching philosophy, strategies, and objectives.
- 3. Comprehensive Curriculum Vitae (with validation from the school administrator or local FAPSA Officer)
- 4. A letter of recommendation from his/her school administrator. (FOR DISTINGUISHED PRIVATE SCHOOL TEACHERS)
- 5. A letter of recommendation from his/her local FAPSA Officer. (FOR DISTINGUISHED PRIVATE SCHOOL ADMINISTRATORS)
- 6. Solo picture Filipiniana Attire (A4 size)

CRITERIA

The HONOREE must Exhibit and Advocate the following characteristics of a worthy Private Educator.

| 3 | Instructional Innovation and Creativity | |
| 4 | High Performance of current students and graduates | |

| 7 | Must not have any pending case involving moral torpitude | |
