**REORIENTATION OF REGIONAL OFFICE PERSONNEL (RO) ON THE EXISTING FUNCTIONAL/OPERATIONAL QA-M&E ASSESSMENT FRAMEWORK**

1. To ensure guidance on the proper implementation of the existing operational Quality Assurance Framework in all RO division and units, this Office, through the Quality Assurance Division (QAD) shall conduct the Two-Day Live-in Reorientation of RO Personnel on the Existing Operational QA-M&E Assessment Framework on March 16-17, 2023 at a venue to be announced in a separate memorandum.

2. The reorientation of the existing operational QA-M&E Assessment Framework specifically aims to:

- a. gain knowledge on the alignment of the existing MEA system operationalizing Basic Education Monitoring and Evaluation Framework (BEMEF);
- b. understand the context of the Theory of Change (ToC);
- c. align REDP strategies and outputs to RO divisions' WFP; and
- d. develop M&E Plan.
