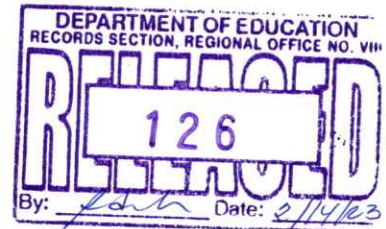
**PARTICIPATION TO THE WRITESHOP ON THE DEVELOPMENT
