1st QUARTER REGULAR MONITORING ON THE IMPLEMENTATION OF SCHOOLS DIVISIONS' 2023 TECHNICAL ASSISTANCE PLANS

To: Schools Division Superintendents
All Others Concerned

- 1. As part of the mechanisms for monitoring the implementation of technical assistance provision in the field, this Office, through the Field Technical Assistance Division (FTAD), shall conduct the 1st Quarter Monitoring on the Implementation of Schools Divisions' 2023 Technical Assistance Plans on March 6 28, 2023.
- 2. The objectives of this activity are to:
 - a. monitor the results of the TA provision to the identified priority schools based on the DFTACTs' TA Provision Plans (DTAPPs);
 - b. conduct inventory of implemented Technical Assistance interventions of the Schools Divisions; and
 - c. monitor the alignment of the 2023 SDO Technical Assistance (TA) Plan by the Division Field Technical Assistance Composite Teams (DFTACTs) to the realtime priorities of the schools.
- 3. Schools Division Offices, through the TA and SBM coordinators shall be informed on the specific schedule prior to the actual visit.
- 4. The participants to this activity are the members of the Division Field Technical Assistance Composite Teams.
- 5. Travel expenses incurred by the RO personnel shall be charged against FTAD Funds while the Schools Divisions' expenses shall be charged against their local funds, subject to the usual accounting rules and regulations.
- 6. Enclosed is the Field Monitoring Tool on Schools Division Technical Assistance (TA) Plan Implementation for reference and guidance.
