1. The Department of Education, Regional Office No. VIII announces that ANA G. YU NATIONAL HIGH SCHOOL, Brgy. Ekiran, Alangalang, Leyte, is a newly approved National High School by this Regional Office on February 28, 2023 through administrative fiat pursuant to its expressed authority under Section 5(B/13) Chapter 1 of RA No. 9155 (Governance of Basic Education Act of 2001), after full satisfactory compliance with the requirements prescribed by existing guidelines and policies of the Department.

2. The Schools Division Superintendent of DepEd Division of Leyte is hereby directed to consider this school in the budget preparation for its eventual inclusion in the immediate succeeding General Appropriation Act (GAA).

3. Immediate dissemination of and strict compliance with this Memorandum are desired.

EVALUATION AND RECOMMENDATION REPORT OF SCHOOL'S APPLICATION

**ESTABLISHMENT OF ANA G. YU NATIONAL HIGH SCHOOL,
BRGY. EKIRAN, ALANGALANG, LEYTE**

BACKGROUND

Alangalang is a second-class municipality in the province of Leyte composed of fifty-four barangays surrounded by bodies of water and mountains, with a population of 57,185 people based on the 2020 census.

There are seven public secondary schools in the municipality with only one in the town proper, and the other schools are located strategically in the different barangays. However, five barangays along the rivers in the northern part namely: Ekiran, Calaasan, Hubang, San Francisco East, and Bughom, and sitios of Kapilihan and Cama-aso, experienced difficulty in sending their children to school because of the distance, transportation cost and “baon”.

Cognizant to the mandate of the Department of Education *to protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all as stipulated in Article XIV, Section 1 of the Philippine Constitution*, Alangalang National High School with the support of the local government unit, conceptualized a program to assure that all school-age children in the far-flung area of the municipality have the access to secondary education.

Further, a temporary extension classes were conducted in the elementary school in one of these barangays while the application documents for the establishment of a secondary school is on process. In response to the school's application, the Regional Inspectorate Team (RIT) conducted an ocular inspection to validate the school's readiness subject to recommendation and appropriate action of the Regional. The following are the findings and recommendations of the ocular inspection conducted:

FINDINGS:

1. One of the residents of Alangalang in Brgy. Ekiran executed a Deed of Conditional Donation in favor of Brgy. Ekiran a parcel of land with an area of 71,553 square meters to be used as the school site of an elementary school.
2. Considering the land area donated, a sizeable portion has not been used. In respect to the family of the donor (Ana G. Yu-deceased), the donee Brgy. Ekiran (current landowner) represented by Punong Barangay Lito A. Alberca and the

legitimate heir Dr. Loreta Y. Rama, executed a deed of Donation in favor of DepEd a parcel of the unutilized lot with an area of 15,530 square meters or 1.553 hectares for the establishment of a secondary school which will be named ANA G. YU NATIONAL HIGH SCHOOL.

3. Based on the death certificate issued by the Office of the Civil Registrar General, Ana G. Yu died on March 18, 2007.
4. The school site has a one-story two-classroom building erected by the LGU of Alangalang.
5. SDO Leyte Division had already deployed four teachers and a head teacher to manage the school operation.
6. The school site has no defined boundaries to show the bounds of the property.

RECOMMENDATIONS:

In view of the foregoing validation, the team respectfully recommends that:

1. The school shall be named **ANA G. YU NATIONAL HIGH SCHOOL** authorized to continue its operation effective School Year 2023-2024.
2. The school shall implement K-12 Basic Education Curriculum
3. School operation shall be on a basis which shall progress to the next grade levels in the succeeding years pending upon availability of classroom/s teacher/s.
4. The Local Government Units both Barangay and Municipal together with the parents shall provide financial support to the school until such time that operations will be covered by the DepEd.
5. The Schools Division Superintendent shall facilitate the transfer of the school site ownership in accordance with the mode of acquisition of school sites provided for in OM-OSEC 2018-0070 Guidelines on the Acquisition of New School Sites, within three months from the approval of the establishment of **ANA G. YU NATIONAL HIGH SCHOOL**.
6. The Schools Division Superintendent shall provide teachers trained in the K to 12 Curriculum and consider additional teachers to this school.


