The Confucius Institute at Angeles University Foundation (CI-AUF), the program partner for Special Program in Foreign Language-Chinese Mandarin (SPFL-Chinese Mandarin), in coordination with the Department of Education, through the Bureau of Curriculum Development, aims to further explore the opportunities and challenges faced in teaching Chinese as a foreign language and contribute to the enhancement of teachers' pedagogical skills.

Given this, the CI-AUF shall stage the 2023 Principals and Supervisors Forum on Special Program in Foreign Language (SPFL) - Chinese Mandarin with the theme: Rethinking Chinese Language Teaching towards the Basic Education Development Plan (BEDP) 2030 and MATATAG Education Agenda, at Angeles University Foundation, Angeles City, Pampanga from March 16 to 18, 2023.

This year's theme focuses on recalibrating the implementation, coordination, monitoring, and evaluation of the SPFL-Chinese Mandarin to contribute to the realization of the DepEd's BEDP 2030. The said conference serves as a venue for SPFL field implementers and other institutions in the Philippines and China, to exchange ideas and further their knowledge.
