ADJUSTMENTS AND CLARIFICATIONS ON THE CONDUCT OF THE LITERACY ASSESSMENTS RELATIVE TO THE PROJECT R8 BULIG (BUILDING AND UPGRADING LEARNING INTERVENTIONS AND GAINS)

To: Schools Division Superintendents All Others Concerned

- 1. In order to sustain the efforts in tracking the learning progress of the learners under the Project R8 BULIG and to respond to the feedbacks shared by the field implementers on the timeline set in the conduct of the series of assessments, this Office, through the Curriculum and Learning Management Division (CLMD), announces the following adjustments and clarifications given below.
 - a. The Mid Assessment is extended until the last week of March 2023.
 - The results of the mid assessment shall be the basis for the division/school intensive reinforcement in April and May 2023.
 - c. The Post Assessment shall be conducted in June 2023.
 - d. Early Grades Reading Assessment (EGRA)
 - For Kindergarten, the learners shall be given Tasks on Book and Print Knowledge, Letter Name and Sound Knowledge, Initial Sound Identification, and Listening Comprehension. The teacher may administer the other tasks for the learners who may have shown readiness in reading words, non-words, and story with comprehension questions.
 - e. Comprehensive Rapid Literacy Assessment (CRLA)
 - In line with the MTB-MLE Program implementation, all the Grade 1 learners must be given CRLA in Mother Tongue; Grade 2 with CRLA in Mother Tongue and Filipino; and Grade 3 with CRLA Mother Tongue, Filipino, and English.
 - f. Philippine Informal Reading Inventory (Phil IRI)
 - The Divisions and schools are advised to come up with contextualized tools for the mid assessments in Grades 3 to 6.
 - Since the region is yet to conduct its workshop on the development of contextualized Phil IRI for high schools, the divisions and schools are



likewise encouraged to develop parallel assessment tools that may capture the literacy progress of the target learners.

- 2. There shall be a separate issuance on the new schedule of the literacy and numeracy assessments administration for school year 2024-2025.
