SUBMISSION OF PROGRAM REQUIREMENTS FOR THE SPED CENTER/SCHOOL TO BE RECOMMENDED FOR THE CONSTRUCTION OF THE INCLUSIVE LEARNING RESOURCE CENTER (ILRC) FOR DEPED'S 2024 BUDGET PREPARATIONS

To: Schools Division Superintendents

All Others Concerned

- 1. In response to the directive in Item Number 3 of DepEd Memorandum DM-CT-2023-062 dated March 29, 2023, the Schools Divisions which have not been included in the first three pilot schools for conversion into ILRCs are given the opportunity to recommend one school for the construction of a new ILRC which will be included in DepEd's 2024 budget preparations.
- 2. In view of the foregoing, the Schools Divisions Offices shall recommend one potential school which meets the following criteria:
  - a. There is enough buildable space following the specifications for the building footprint and land dimension stipulated in Item No. 3 in the said issuance;
  - The site of the SPED Center or any school with available space shall be duly owned by DepEd;
  - The location of the school must be in a strategic place that can easily be accessed by learners with disabilities (LWDs);
  - d. The school must be compliant with the applicable minimum requirements and criteria mentioned in DepEd Order No. 45, Series 2021; and
  - e. The school is nominated/endorsed by the Schools Division Superintendent.
- 3. Due to the forthcoming deadline at the Central Office, the first SPED Center/School that meets all the requirements, submitted through <a href="mailto:clmd.region8@deped.gov.ph">clmd.region8@deped.gov.ph</a> not later than the conduct of the virtual meeting with the Division SPED Supervisors at 1:30 3:30 p.m. on April 13, 2023 via Google Meet, shall be recommended to the Bureau of Learning Delivery-Student Inclusion Division which, in turn, shall confirm the school's inclusion in DepEd's 2024 budget preparations.
- 4. Other schools which have also been found compliant shall be considered for the succeeding batches during the same virtual meeting.
- Immediate dissemination of and compliance with this Memorandum are desired.

In line with Republic Act (RA) No. 11650 otherwise known as "Instituting a Policy of Inclusion and Services for Learners with Disabilities..." and the Vice President and DepEd Secretary Sara Z. Duterte's MATATAG Agenda, particularly on the component: **TA**ke good care of learners by promoting learner well-being, inclusive education, and a positive learning environment, the Department of Education (DepEd) through the Bureau of Learning Delivery - Student Inclusion Division (BLD-SID) is currently expanding the conversion of SPED Centers into Inclusive Learning Resource Centers (ILRCs) and planning to commence the construction of ILRC for Fiscal Year (FY) 2024.

- 3. One (1) school with buildable space for the construction of an ILRC for FY 2024 nominated by the Regional Director which requires a bldg. ft. print of at least 453.88sqm, land dimensions requirement of 51m (L) by 15m (D) incl setbacks of 4.5 front setback if rrow (road right of way); and
- Enclosed is the list of SPED Centers for conversion into ILRC per Region for FY 2024 for your confirmation through a letter signed by the Regional Director.

Due to its forthcoming deadline for submission to the Department of Budget and Management (DBM), it is earnestly requested that all the **aforementioned** documents shall be submitted to this Office on or before April 15, 2023.
