**MONITORING ON THE IMPLEMENTATION OF INCLUSIVE EDUCATION
 PROGRAMS IN THE DIVISIONS OF MAASIN CITY AND SOUTHERN
 LEYTE AND PARTICIPATION TO THE ADMINISTRATION OF BRAILLE
 READING ASSESSMENT AND EARLY GRADE READING
 ASSESSMENT (EGRA) FOR THE DEAF**

To: Schools Division Superintendents
 - Division of Maasin City
 - Division of Southern Leyte
 All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a monitoring on the implementation of inclusive education programs in some selected schools in the Divisions of Maasin City and Southern Leyte and participate in the administration of a Braille Reading Assessment and EGRA for the Blind on April 17-21, and April 24-27, 2023 in the Divisions of Maasin City and Southern Leyte.

2. The activity aims to realize the following objectives:

- a. Do a field monitoring on the implementation of Special Education (SpEd) Program, Indigenous Peoples' Education (IPEd) Program, and Muslim Education Program (MEP) in the Divisions of Maasin City and Southern Leyte;
- b. Gather data from the schools implementing inclusive education;
- c. Conduct an ocular inspection of San Juan SPED Center which has been identified as the next pilot school for conversion into an ILRC per DepEd Memorandum DM-CT-2023-062;
- d. Assist Gabay Project personnel in the administration of reading assessment tools to identified blind and deaf learners; and
- e. Strengthen partnership with stakeholders and sponsors and explore opportunities for future collaboration.

3. The expected participants in this activity include the Regional and Division Focal Persons of the SpEd, IPEd, and Muslim Education Programs, School Personnel from the selected schools, blind and deaf learners who will undergo the reading assessment, and Gabay Project Partners.

4. Travel expenses of the Regional participants shall be charged against the 2022 SpEd Program Support Funds while those of the Division participants may be

charged to their respective local funds or other applicable sources funds, subject to the existing accounting or auditing rules and regulations.
