- 1. The LRMS Librarian and PDO II, in coordination with the Learning Area Education Program Supervisors shall continuously update the Summary of Finalized Division Contextualized Learning Resources (DCLRs) and its accomplished evaluation and field testing tools, which can be accessed through the link: https://bit.ly/SDO-SUMMARY-DCLRs-2023.
