





# MONITORING OF THE CUSTOMER/CLIENT SATISFACTION SURVEY RESULTS

- To ensure efficient and effective delivery of basic education services and sustain client satisfaction through implementation of the Quality Management System, this Office, through the Public Affairs Unit shall regularly monitor the customer/client satisfaction survey results.
- All DepEd Regional Office employees shall be responsible for ensuring the accomplishment of Customer/Client Satisfaction Survey Form by internal and external clients for all transactions.
- The Office shall provide two tablets in the Visitors' Lounge (For online filling out) and offline version of the CCSS Form.

- The Public Affairs Unit shall take charge in the monthly monitoring and consolidation of the Customer/Client Satisfaction Survey Results and report the said results during REXECOM meetings and Management Reviews.
