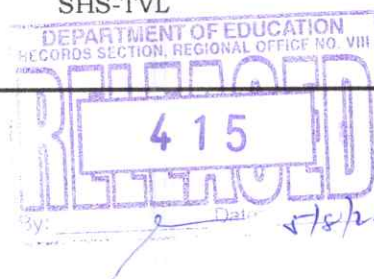

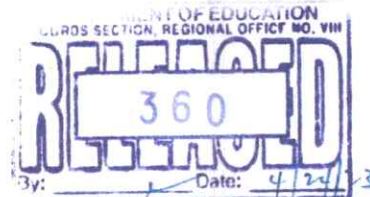



No. 7160 or An Act Providing for a Local Government Code Of 1991 Book 2 Section 381, which states:
