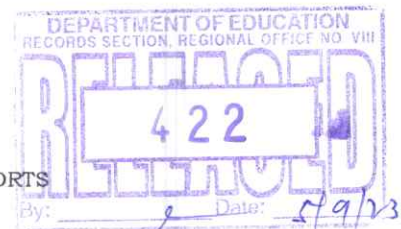
**ADDENDUM TO REGIONAL MEMORANDUM NO. 407,

**FINAL DELIBERATION OF THE 2023 EVRAA MEET WINNING ATHLETES**

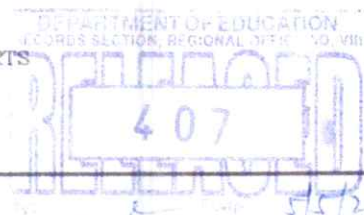
To: Schools Division Superintendents

1. In consonance with the conduct of the 2023 Palarong Pambansa, this Office, through the Curriculum and Learning Management Division (CLMD), shall hold a Final Deliberation of the 2023 EVRAA Meet Winning Athletes on May 10, 2023 at the Leyte National High School AV Hall, Tacloban City.
2. The activity aims to:
  - a. conduct final deliberation of documents of the 2023 EVRAA Meet winning athletes;
  - b. discuss the process of evaluation and verification in terms of the authenticity of the documents of winning athletes, coaches, assistant coaches, and chaperons, submitted by the DSO for the 2023 Pre-Palarong Pambansa;
  - c. accredit qualified athletes, coaches, assistant coaches, and chaperons based on the submitted list of the head of the delegation that will be forwarded to the Palarong Pambansa Secretariat; and
  - d. discuss other related matters.
3. The participants of the aforesaid activity are the Regional Sports Officer (RSO), Assistant Regional Sports Officer (ARSO), Division Sports Officers (DSOs), Tournament Managers (TMs), and Regional Selection and Accreditation Committee (RSAC) members.
4. Travel and other expenses to be incurred in the conduct of the aforesaid activity shall be charged to the downloaded Palarong Pambansa Funds or local funds/MOOE subject to the usual government accounting and auditing rules and regulations.
