CONDUCT OF RELIGION CLASSES FOR SCHOOL YEAR 2023-2024

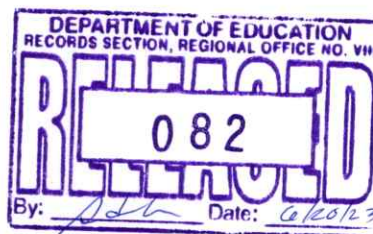
