**CONSULTATIVE MEETING ON THE UTILIZATION AND ENHANCEMENT
OF THE EARLY GRADES READING ASSESSMENT
(EGRA) TOOLS AND DASHBOARD**

To: Schools Division Superintendents
All Others Concerned

1. Relative to the attached Regional Memorandum No. 1321, s. 2022 on the Orientation-Workshop on the Utilization of the Early Grades Reading Assessment (EGRA) and Regional Memorandum No. 096, s. 2023 re: Regional Training Workshop on the Submission of Literacy Data through the EGRA Dashboard, this Office, through the Curriculum and Learning Management Division (CLMD), announces the conduct of the Consultative Meeting on the Utilization and Enhancement of the EGRA Tools and Dashboard on June 8, 2023 via Google Meet.
2. The activity aims to:
 - a. review and validate the data generated from the EGRA Dashboard;
 - b. gather significant feedbacks on the utilization of the EGRA tools and dashboard;
 - c. enhance the tools, if necessary; and
 - d. discuss other matters relative to literacy and Project R8 BULIG implementation.
3. The participants to the activity are the Regional and Division MTB-MLE Program Coordinators. There shall also be four (4) teachers (one teacher per grade level) per division.
4. The teacher-participants are expected to bring their curriculum guides and other learning resources as reference to the enhancement of the EGRA tool.
5. Each of the Schools Division Offices is required to gather and prepare a consolidated report on the teachers' feedback (good points, areas for improvement, and suggestions/recommendations) as regards utilization of the EGRA tools and dashboard in slide decks to be presented within 3-5 minutes.
6. Attached is the matrix of activity for guidance.



7. The Schools Division Offices, through the School Heads, shall ascertain that no classes are disrupted by adopting effective measures such as merging of classes or assigning temporary teachers/learning support aides to ensure that learners still obtain the full benefit of instruction.
8. The links to the pre-work, activity platform, and registration shall be shared to the Division Coordinators through the Facebook Group Chat.
9. Immediate dissemination of and strict compliance with this Memorandum are desired.

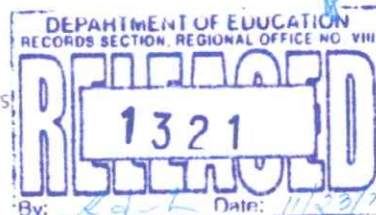
**ORIENTATION - WORKSHOP ON THE UTILIZATION OF THE EARLY

1. This Office, through the Curriculum and Learning Management Division (CLMD) and in coordination with the United Nations Children's Fund (UNICEF) shall conduct an Orientation on the Utilization of the Early Grade Reading Assessment (EGRA) Dashboard on November 29, 2022 at the Division Library Hub, DepEd Tacloban City Division, Real St., Tacloban City.
