- 2.2Ensure that teachers are provided with and/or referred to adequate information technical and legal assistance in the course of the performance of their duties as members of the Electoral Board;
- 2.3 Serve as DepEd institutional link to volunteer organizations and individuals;
- 2.4Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, and partner agencies involved in the 2023 BSKE; and
- 2.5 Complement the other government agencies' efforts for an honest, orderly, and peaceful elections.
- 3. The schedule of duty of the BSK-ETF shall start at 1:00p.m. on October 29, 2023, and end at 5:00p.m. on October 30, 2023.
- 4. Expenses for meals, grant of honoraria, and other necessary expenses incurred by the BSK-ETF shall be subject to existing Commission on Audit rules and regulations, as well as issuances from the Department of Budget and Management relative to the matter. Payments of overtime or grant of compensatory time-off are authorized, subject to the availability of funds and existing auditing rules and regulations, including applicable Civil Service laws.
