In support of the Department of Education's (DepEd) commitment to ensuring equal access for all learners at risk of dropping out of basic education, the Bureau of Learning Delivery (BLD) will conduct the Program Implementation Review on School-Initiated Intervention (SII) on October 11-13, 2023 in Cavite. A separate memorandum will be issued for its final details.

The activity aims to:

1. evaluate whether the SII is achieving its objectives;
2. examine how effective SII is in decreasing the dropout rate; and
3. identify strategies to improve the intervention.

In line with this, this Office would like to request the following participants from your region:

- a. One (1) elementary school principal implementing SII;
- b. One (1) secondary school principal implementing SII from the Secondary Education Development and Improvement Project (SEDIP) division; and

Participants in this activity should be from implementing schools included in DMCI - 2022- 406 issued on November 10, 2022, and should have knowledge of the implementation of the SII.
