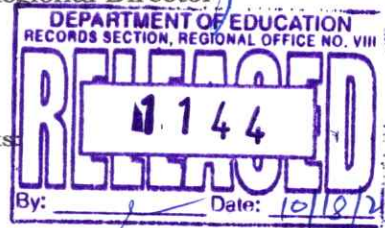

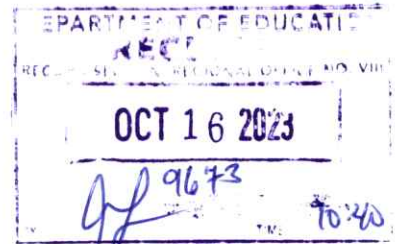

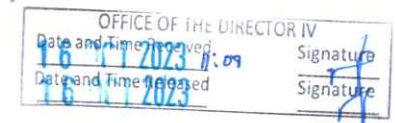

All forms shall be submitted on or before October 11, 2023. The list of teachers to take the exam is seen in **Annex A**. Likewise, attached are the **application form** and **DELE waiver**.

Given that exam is a Saturday, examinees are entitled for service credits pursuant to DO 53, s. 2003. Further, travel and travel related expenses for the examination shall be charged against available local funds subject to usual accounting and auditing procedures.
