- Each SDO shall be notified through the Division TA Coordinator as to who among the DFTACT members shall participate in the activity based on the RFTACT's TA Plan.
- Travel expenses of the RFTACTs and expenses incurred in the conduct of the activity by the DFTACTs shall be charged to their Local Funds, subject to the usual accounting and auditing rules and regulations.


