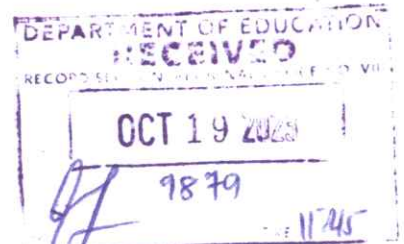

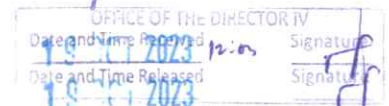

1. This is to inform you that the **3<sup>rd</sup> Eastern Visayas Regional Planning Forum (RPF)** for the FY 2025 Budget Preparation will be conducted on **06-07 November 2023 via Zoom**.
2. During its 3<sup>rd</sup> quarter 2023 joint meeting, the RDC VIII and RDRRMC VIII approved the conduct of the RPF through Joint Resolution No. 51, Series of 2023. The activity shall be initiated by the Council's Regional Inter-Agency Task Force on Planning and Budgeting (RIATF-PB).
3. The forthcoming Forum is the third round of the RPF as a venue to ensure national, regional, and local formulation of development policies and programs and projects (PAPs), and continuous improvement of agencies and local government units' (LGUs) understanding of the processes in crafting sound and implementation-ready FY 2025 budget proposals.

Sessions during the said Forum will center on the linkages of development plans, investment programs, and budgets; prior years' budgeting experience; guidelines, techniques, and facilitative processes in preparing quality and adequately supported FY 2025 budget proposal. 
