**RENAMING OF LUGSONGAN ADVENTIST MULTIGRADE SCHOOL TO
ADVENTIST ELEMENTARY SCHOOL-LIMASAWA, INC.**

To: Schools Division Superintendent
All Others Concerned

1. In reference to the approved Securities and Exchange Commission (SEC) Registration No. 2023050098256-54 of Lugsongan Adventist Multigrade School located at Purok 1 Lugsongan, Limasawa, Southern Leyte, Region VIII (Eastern Visayas), through the Quality Assurance Division (QAD) announces the change of name of the school from Lugsongan Adventist Multigrade School to Adventist Elementary School-Limasawa, Inc. effective September 13, 2023.
2. To preserve the historicity, it is advised that the old name of the school, which has been sanctified by usage by the residents of the community, be placed beneath the new name as follows:

ADVENTIST ELEMENTARY SCHOOL-LIMASAWA, INC.
(Formerly: Lugsongan Adventist Multigrade School)

3. The change of name does not instill any deviations on the provisions of the Government Recognition given to the school. Thus, Government Recognition No. 02, series 1988 for Elementary still remain legal and official.
4. Copies of this issuance shall be posted at the Regional Office, Division Offices, Town Halls, Schools and other conspicuous places for reference and information of the general public.
5. The Schools Division Superintendent of Southern Leyte Division shall ensure the updating of the data and profile of the aforementioned school in the Enhanced Basic Education Information System (EBEIS) and Learners Information System (LIS) and monitor the implementation of the said issuance.
6. Immediate dissemination of and compliance with this Memorandum are desired.

were duly approved by the Commission on this date upon the issuance of this Certificate of Incorporation in accordance with the Revised Corporation Code of the Philippines (Republic Act No. 11232), which took effect on February 23, 2019 and copies of said Articles of Incorporation and By Laws are hereto attached.

This Certificate grants juridical personality to the corporation but does not authorize it to issue, sell or offer for sale to the public, securities such as but not limited to, shares of stock, investment contracts, debt instruments and virtual currencies without prior Registration Statement approved by the Securities and Exchange Commission; nor to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing/lending company, and time shares/club shares/membership certificate issuers or selling agents thereof; nor to operate a fiat money to virtual currency exchange. Neither does this Certificate constitute a permit to undertake activities for which other government agencies require a license or permit.

This Certificate DOES NOT AUTHORIZE INVESTMENT SOLICITATION AND INVESTMENT-TAKING WITHOUT A SECONDARY LICENSE FROM THIS COMMISSION.

As a registered corporation, it shall submit annually to this Commission the reports indicated at the back of this certificate.

Articles of Incorporation
of
Adventist Elementary School - Limasawa, Inc.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock corporation under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

First: That the name of said corporation shall be

Adventist Elementary School - Limasawa, Inc.

Second: That the purpose or purposes for which such corporation is incorporated are:

To operate a school that offers kindergarten, elementary, junior and senior high school education in accordance with the K to 12 program of the DepEd. The registration of the Articles of Incorporation of the corporation shall not be construed as a grant or permit to operate the school/institution of learning. The establishment, operation, administration and management of the said school/institution of learning shall be subject to the existing laws, rules and regulations, policies and standards of the DepEd which shall be complied with before said institution of learning may be allowed to operate. Said compliance shall be evidenced by a certificate to be issued by the DepEd.

Provided that the corporation shall not solicit, accept or take investments/placements from the public neither shall it issue investment contracts.

Third: That the principal office of the corporation is located in **PUROK 1 LUGSONGAN, LIMASAWA, SOUTHERN LEYTE, REGION VIII (EASTERN VISAYAS), 6618:**

Fourth: That the corporation shall have a term of existence of **fifty (50)** years from the date of issuance of the certificate of incorporation;



Seventh: That the total contribution of the corporations is Seven Hundred Fifty Thousand Pesos (P750,000).

Eighth: That LAARNI DACERA DE LEON has been elected by the members as Treasurer of the corporation to act as such until his successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the corporation, all contributions or donations paid or given by the members.

Ninth: That no part of its income is distributable as dividends to its members, trustees or officers subject to the provisions of the Revised Corporation Code of the Philippines on dissolution. Provided, that any profit obtained by the association as an incident to its operation shall, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Revised Corporation Code of the Philippines.

Tenth: That the incorporators undertake to change the name of the corporation, as herein provided or as amended thereafter, immediately upon receipt of notice from the Commission that another corporation, partnership or person has acquired a prior right to the use of such name that the name has been declared not distinguishable from a name already registered or reserved for the use of another corporation, or that it is contrary to law, public morals, customs or public policy.
