ACCOMPLISHMENT REPORT (GAD-AR)**

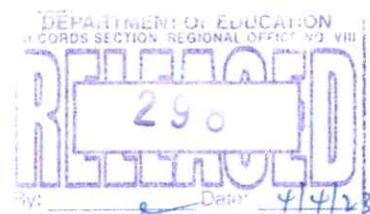
