**UPDATE ON THE DESIGNATION OF THE SCHOOLS DIVISION'S
TECHNICAL ASSISTANCE (TA) FOCAL PERSON**

To: Schools Division Superintendents
All Others Concerned

1. As an upshot of the issues and concerns resolved during the Consultative Conference with the CID and SGOD Chiefs, TA, and SBM Coordinators of the School Division Offices (SDOs), this Office, through the Field Technical Assistance Division (FTAD), hereby informs all SDOs that the Schools Division Superintendents may designate an EPS, SEPS or EPS II of the SGOD who has the skill of organizing the DFTACTs under the direct supervision of the SGOD Chief, and in coordination with the CID Chief, as the SDO-TA Coordinator.
2. However, if the current TA coordinator is capable of handling the responsibilities embedded in the designation, he/she shall be retained.
3. In view of this, all SDOs that shall designate a new TA Coordinator shall submit the scanned copy of the designation through this email address, ftad.region8@deped.gov.ph.
4. Immediate dissemination of and compliance with this Memorandum are desired.
