REGIONAL REGULAR MONITORING OF OPLAN KALUSUGAN SA DEPED (OK SA DEPED) FLAGSHIP PROGRAMS IMPLEMENTATION FOR 2024

- 1. In compliance with, DepEd Order No. 28, s. 2018 titled "Policy and Guidelines on Oplan sa Kalusugan sa Department of Education (OK sa DepEd)" and DepEd Order No. 31, s.2021 titled "Operational Guidelines on the Implementation of School-Based Feeding Program", this Office, through the Education Support Services Division-School Health and Nutrition Unit (ESSD-SHNU), shall conduct a Regional Regular Monitoring of Oplan Kalusugan sa DepEd (OK sa DepEd) Flagship Programs Implementation for 2024, particularly on Medical, Dental and Nursing Services, National Drug Education Program (NDEP), Adolescent Reproductive Health (ARH), Wash in Schools (WinS), School Mental Health, School-Based Feeding Program (SBFP), Integrated School Nutrition Model (ISNM), and Gulayan sa Paaralan Program (GPP).
- 2. This activity aims to monitor the implementation of the aforementioned programs, and to provide technical assistance to the Schools Division Offices (SDOs) on implementing the School-Based Feeding Program and OK sa DepEd Flagship Programs in the Schools Division Offices and schools within their jurisdiction.
- 3. The Monitoring Teams shall comprise the ESSD Chief, Medical Officer, Dentist, Nutritionist-Dietitian, Nurse, Dental Aide, and other Program Focal Persons. The Monitoring Tool is enclosed for your reference.

- 5. Travel expenses of the Monitoring Teams shall be charged against the Program Support Funds of SBFP and/or RO-ESSD funds, subject to the usual accounting and auditing rules and procedures.
