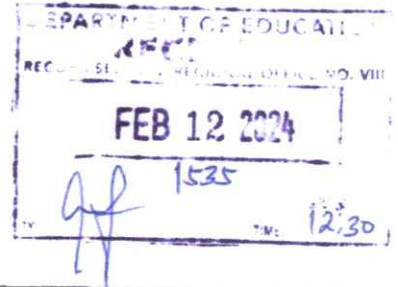

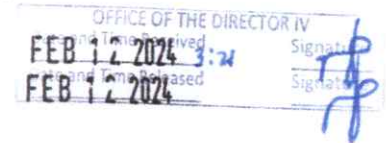

This is in reference to the Memorandum Circular (MC) No. 2024-01 titled *Accomplishment and Online Submission of Fiscal Year (FY) 2023 GAD Focal Point System (GFPS) Profile Form*, issued by the Philippine Commission on Women (PCW), instructing Executive Departments, National Line Agencies, Attached Agencies, GOCCs, Legislative and Judiciary Branches, Constitutional Bodies, and SUCs to accomplish the online FY 2023 GAD Focal Point System Profile Form.

PCW's primary objective for this process is to collect data that will serve as a basis or input for potential future amendments or enhancement to existing policy issuances and related guidelines concerning the GFPS. 2. Policy issuances relative to the GFPS from FY 2020- 2023, and
3. GFPS GAD-Related Capacity Development attended.
