4. Immediate dissemination of and compliance with this Memorandum are desired.

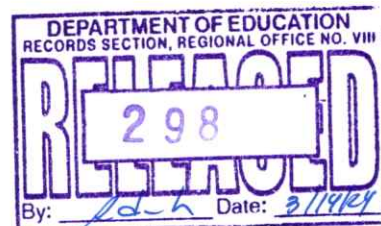

This is in reference to the letter of Mr./Ms. Jemmar Java De Asis regarding the conduct of HEEADSS Assessment to learners at Ormoc City Senior High School last November 17, 2023. The results identified 22 learners with a history of self-harm; yet, a delayed response from the Guidance Office was reported.

While we acknowledge that assessment is a key component of a holistic wellbeing promotion and service delivery, we would like to reiterate that **mass administration of HEEADSSS should be limited to schools with established referral systems** to ensure that learners who have been identified to be at risk are provided with appropriate and timely interventions.

Further, **we request a report on the conduct of the HEEADSSS assessment**, including the interventions provided to the 22 learners and/or a request for technical assistance as necessary. **Kindly submit the report by March 13, 2024 (Wednesday)** through email (blss.shd@deped.gov.ph | cc: schoolmentalhealth@deped.gov.ph).

Ang aking pagkakamali sa pakikipag-ugnayan sa kanya dahil hindi ko naipabatid sa aming Guidance Designate Counselor ang aking ginawa at siya ay walang alam dito na ako'y nakipag-ugyan sa kawani ng UNICEF, at hindi ko naisip ang tamang protocol na dapat sundin lalo na dahil may kinalaman sa usaping mental health. Sa katanungan ang aming paaralan ay may ginawa na mga hakbang para matulungan ang mag-aaral na sumagot ng YES at ito pala ay buwanang gawain at sa susunod na buwan ay ang aking seksiyon na ang sasalang para sa *Psychosocial at Mental Awareness* at ito'y aking nakalimutan na may nakasalang na pala na gawain para sa aking mga mag-aaral.

Isa din sa aking pagkakamali ay hindi ko naipasa ang resulta sa HEADSS na isinagawa na dapat ay na validate muna ito ng aming guidance counselor upang matukoy kung ano-ano ba ang sanhi at o dahilan bakit sila sumagot ng YES.

Pangalawa, nalimutan ko din na ang aming SDO ORMOC sa pangunguna ni Mam Mae Esther Arones na koordeynitor sa programang Mental Health advocate ay may mga gawain na nakasalang at ito'y on going implemented na para lalong mag-alab ang adhikain na matulungan ay mga mag-aaral na may balakid sa usaping mental. At sila ay susog upang masugpo ang kanser na ito na lumalamon sa usaping mental ng mga kabataan.


