**TRAINING WORKSHOP ON THE INTEGRATION OF COMPREHENSIVE
SEXUALITY EDUCATION (CSE) IN THE KTO12 BASIC
EDUCATION CURRICULUM**

To: Schools Division Superintendents
All Others Concerned

1. This Region, through the Education Support Services Division (ESSD) Special Programs and Projects Section (SPPS) and the Curriculum and Learning Management Division (CLMD), in partnership with the Global Care, shall conduct a **2-Day Training Workshop on the Integration of Comprehensive Sexuality Education (CSE) in the Kto12 Basic Education Curriculum (BEC)** on April 12-13, 2024 at the Madison Park Hotel, Tacloban City.
2. This activity, which is a continuation of the CSE training in 2023, aims to:
 - a. capacitate the teachers on sex education and communication with adolescents;
 - b. identify entry points of CSE standards in the Kto12 MELCS; and
 - c. conduct a walk-through of CSE DLP, LAC CSE Modules, and Lesson Exemplars.
3. The participants to this activity are eight subject teachers per school from Grade 8, Grade 9, and Grade 10 in the following schools in Leyte Division:
 - a. Granja-Kalinawan National High School- 8 pax
 - b. Barugo National High School - 8 pax
 - c. Carigara National High School - 8 pax
 - d. Carigara National Vocation School - 8 pax**32 pax**

All the participants shall be provided with meals and accommodation charged against the fund of the **Global Care**, while their travel and other incidental expenses shall be charged against their respective MOOE/ Local Fund/ Partnership Fund/ SEF, subject to the usual government rules on accounting and auditing procedures.

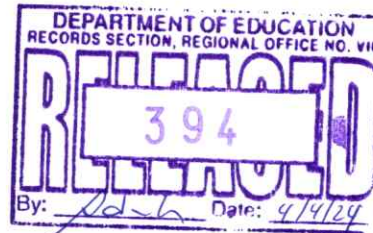
