The preparation of the meeting and PPA5 assessment venues, food, and other requirements which shall include the facilitation of the learners, teachers, and guests as presented in the table above shall be taken care of by the Schools Divisions of Borongan City and Eastern Samar, while the food during the first and last day, accommodation, and transportation of the monitors shall be arranged by the Regional Office of which expenses shall be charged against the **downloaded ALS Funds** at the respective offices, subject to the usual accounting and auditing rules and regulations.
