EVALUATION AND RECOMMENDATION REPORT OF SCHOOL'S APPLICATION

Name of School

: BURI ELEMENTARY SCHOOL

FINDINGS:

1. Barangay Buri in the municipality of Alangalang is the only barangay without an elementary school;

- 2. The barangay is situated beyond two kilometers from the nearest public elementary school;
- 3. In September 2015, the then Barangay Chairman Virgilio Vergara representing Barangay Buri purchased a 4,582 square meters parcel of land for 150,000.00 pesos;
- 4. In April 16, 2023, Barangay Chairman Christopher G. Breva executed a Deed of Donation in favor of the Department of Education, represented by Schools Division Superintendent Dr. Mariza S. Magan, for the establishment of an elementary school;
- 5. Currently, the school site has been erected with a 1-room 1 storey school building funded by the LGU barangay;
- 6. The school has an approved program of work for the construction of one building classroom to be funded by the provincial government of Leyte, to be implemented in the 2nd quarter of 2024;
- 7. The school is conducive to learning, as the site is free from noise, unpleasant odors, and distractions;
- 8. The school does not have laboratories and a perimeter fence to define the school boundaries, but there is buildable space for possible expansion of curricular offerings in the future;
- 9. The Municipal Local Government Unit pledges financial assistance to cover all school-related expenses, including constructing new school buildings, procuring educational facilities, furniture, instructional materials, and maintenance for at least five years or until funds are allocated in the National Budget;

- 10. The Schools Division Superintendent of Leyte Division commits, through a Memorandum of Agreement with the Municipal Local Government Unit, to work for the school's funding requirements for personnel services and other operating expenses;
- 11. The Schools Division Superintendent shall ensure the designation of an Officer-In-Charge of the school and the deployment of teachers.

RECOMMENDATIONS

In view of the foregoing evaluation and findings, the team respectfully recommends that:

- 1. The school shall be named Buri Elementary School and is authorized to operate effective School Year 2024-2025;
- 2. The opening of the newly established school shall be on a gradual basis, starting with Grade 1 for School Year 2024-2025. The progression of expansion for the following grade levels shall depend on the availability of required resources and approval from the Schools Division Superintendent;
- 3. The Schools Division Superintendent of Leyte shall provide teachers trained on the K to 12 Curriculum for the establishment of Buri Elementary School;
- 4. The Schools Division Office shall provide school buildings, chairs, textbooks, and other resources to the newly established school;
- 5. The school shall be considered in the budget preparation for its inclusion in the immediate succeeding General Appropriation Act (GAA);


