**PARTICIPATION OF EVRAA DELEGATION TO THE
2024 PALARONG PAMBANSA**

1. This Office, through the Education Support Services Division (ESSD) announces the participation of the Eastern Visayas Regional Athletic Association (EVRAA) to the 2024 Palarong Pambansa to be hosted by the local government of Cebu City on July 5-17, 2024.

2. The EVRAA Delegates which include Delegation Officials, Athletes, Coaches, Assistant Coaches, Chaperons, Division Sports Officers (DSOs), and Regional Office Technical Working Group (TWG) will depart from Ormoc City Port to Cebu City Port and depart from Cebu City to Ormoc City in different trips as shown in the following table:

Four Hundred (400) Delegates	From Cebu City to Ormoc City July 16, 2024- 10:00 PM Trip via boat	Billeting School
Two Hundred Seventy (270) Delegates	From Cebu City to Ormoc City July 17, 2024- 10:00 AM Trip via boat	Billeting School

3. All the 2024 Palarong Pambansa participants shall follow the preventing health protocol in the locality, and are advised to attend the opening and closing ceremonies.

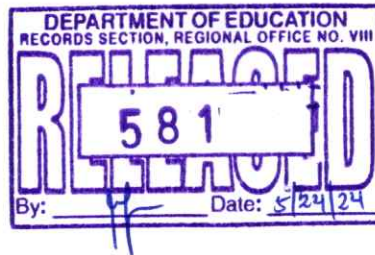
4. Another regional memorandum containing the list of the 2024 Palarong Pambansa delegates shall be issued.

5. Expenses for the travel, food, insurance, uniform and other expenses of the delegates shall be charged against the downloaded Palarong Pambansa Funds, Division/School MOOE, Local Funds or other applicable sources of funds, subject to the existing accounting and auditing rules and regulations.

Moreover, the participants to this activity who travel or render services on days that fall on weekends and holidays can avail of the Service Credits, CTO or COC equivalent to eight hours of service per day whichever is applicable for DepEd Order No. 67, s. 1988 and CSC Memo Circular No. 09, s. 1988.
