This has reference to the Development of Positive Discipline (Pos-Di) Learning Action Cell (LAC) Session Guides spearheaded by the DepEd Learner Rights and Protection Office (LRPO) in coordination with the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) following the Department of Education's (DepEd) mandate of practicing positive discipline in public and private schools1, and DepEd's MATATAG Agenda of "Make the curriculum relevant to produce job-ready, active, and responsible citizens," and "TAke good care of learners by promoting learner wellbeing, inclusive education, and a positive learning environment." the Learner Rights and Protection Office (LRPO) in coordination with the Bureau of Learning Delivery through the Teaching and Learning Division (BLD-TLD) spearheaded the development and refinement of the PosDi-LAC Session Guides, to promote positive discipline in schools.

As you may recall, this Office, last July 2022 conducted a consultation and workshop on the Development of the PosDi-LAC Session Guides to aid our teachers in the construction of new knowledge on classroom management and revise traditional beliefs on corporal punishment. This was followed by the actual Writeshop last August, 2022, and thereafter Refinement last October, 2022. In continuity, this
